A week after Mother Margaret Regina's departure, the Little Sisters, Residents, and staff gathered at the front door of our Home on July 9 to welcome Mother Patricia Mary. The moment her van was spotted coming up our driveway, several employees began ringing the Home's bells, a longstanding tradition!

Mother Patricia Mary was greeted by our centenarian Emma, holding



a big floral bouquet, and longtime Resident Carl, with a warm smile. Monsignor Joaquin Bazan greeted her in the lobby and offered a few words in the name of all.

The following day our welcome continued with entertainment by Residents, staff, and volunteers.

A group of staff members blended magnificent harmonies in a traditional Christian Jubilee song; our Resident pianist, Susan, played an Ave Maria; and one of our newest Residents, Patrice performed a contemporary song based on St. Matthew's Last Judgement scene. Christina, a Korean lay associate, performed a Korean dance, and our Hispanic staff members donned dresses reflecting their home countries for a song performed in Spanish. It was all a beautiful expression of the spirit of our Home!

Rising to the Challenge

The Critical Need for a New Elevator

We are immensely grateful for the ongoing support of our friends and benefactors. Thanks to your generosity, we are currently making considerable progress on the vital restoration of our air conditioning system. However, we must now turn our attention to another pressing need - replacing our oldest elevator.

Installed in 1964, it is the last-of-four elevators in our Home that require modernization. Unfortunately, its outdated components have led to more frequent malfunctions and breakdowns. These challenges affect the Sisters living in the convent and the Residents of St. Joseph's Villa, our Independent Living Apartments, who rely on this elevator for mobility throughout the Home.

We have obtained one bid from a qualified contractor, which exceeds \$470,000. We are awaiting two additional bids to ensure we make the bestinformed decision for this essential project.

The scope of the project includes removing the existing elevator system and installing a modern, compliant elevator that meets current safety standards. The new system will feature a microprocessor controller with built-in diagnostics, a geared hoisting machine, and a rope gripper to prevent over-speeding and unintended car movement. Upgrades to the elevator shaft and related infrastructure will ensure long-term reliability and safety for all users.


"Katie is an inspiring addition," said Mother Patricia Mary. "She embodies the spirit of compassion and service that defines the Little Sisters of the Poor."
